



# MESSAGE TO NATIONAL MODEL UNITED NATIONS • DC (NMUN • DC) 2020 CONFERENCE

#### Washington, DC: 6-8 November 2020

Our world faces an unprecedented crisis that is causing widespread human suffering, upending lives, devastating the global economy and risking reversals of hard-won progress towards the Sustainable Development Goals.

In these trying times, I welcome the holding of your Model United Nations activity. Your unwavering commitment to international cooperation is essential for tackling the COVID-19 pandemic -- the biggest test our world has faced since the Second World War.

Dear Delegates, Faculty Advisors, Guests, and Friends,

On behalf of our entire volunteer staff, I am excited to welcome you to the 2020 NMUN•DC Conference! In September, the United Nations General Assembly held its first ever general debate completely online. Just as the work of the "real" UN continues virtually, NMUN will continue conducting a realistic simulation exercise as it has since before the second World War. Our hope for this weekend remains to provide you with an engaging environment to discuss some of the world's most pressing challenges.

This year's conference convenes during a time of extreme strain on the international system including a pandemic not seen for a century. In some ways, COVID-19 has introduced new challenges while in others it has exacerbated existing issues. Climate change, income inequality, and political instability continue to be significant challenges across the world. Governments have continued to look inward to solve these problems, rather than relying on the international order which has served the international community for over 75 years. Despite these seemingly overwhelming number of crises the international community faces in this era of diminished global leadership, I remain confident that these challenges can be overcome.

I have always thought the greatest strength of the UN to be the value it places on consensus building. Resolutions are not usually adopted through simple majority, but rather by consensus with all 193 Member States coming together to decide the best action. The power of documents like the Universal Declaration of Human Rights and Sustainable Development Goals are not in the values described or actions proposed, but the mutual trust Member States place in each other. The enforcement mechanism of these documents are good faith actors choosing to live up to these standards. Even today, when trust and faith within the international system is low, I remain confident in its ability to solve these challenges--not because of its past success, but because each year at NMUN I witness firsthand a future generation of leaders who remain committed to these ideas.

Over this weekend you will have the opportunity to practice the leadership skills necessary for creating lasting positive change in the world. No matter what you do after your collegiate career is over, knowing how to lead effectively by achieving consensus to solve problems is necessary to implementing solutions. The UN was founded on engaging with all parties, not the just the ones who you agree with the most. This weekend I challenge all of you to take on this extremely difficult task of exhibiting leadership to build consensus in solving the world's most pressing challenges. I look forward not only to seeing your success this weekend, but to seeing all of you apply your skills as a leader to create lasting and positive change in the "real" world very soon.



## **Conduct Expectations**

#### Delegates

- Our intention is to create an environment at National Model United Nations (NMUN) that supports our educational mission. Professionalism in speech, actions, and appearance by all participants (delegates, head delegates, faculty, delegation leaders, guests, secretariat, staff, and board members) is a requirement of all NMUN conferences. These guidelines are provided to help establish clear expectations.
- Concerns about individual behavior in committee should first be addressed to the volunteer staff in committee. Larger concerns, such as violence, sexual harassment, or discrimination issues, may be referred to conference organizers. Organizers may also be contacted directly through information services volunteer staff.

NMUN reserves the right to bar violators from further participation and/ or restrict future registration for any participant or school unable to uphold their responsibility to the conference's expectations.

#### **Everyone**

- Treat everyone with the highest level of courtesy and respect at all times, including on social media and in electronic communications.
- Please bear in mind that the purpose of attending is participation in NMUN.
- Disruption of committee sessions or causing problems will not be tolerated.
- · Respect academic integrity; plagiarism will not be tolerated.
- Alcohol is not allowed in any of our committee sessions. If you are going to drink, please drink responsibly. Excessive alcohol consumption should be avoided. The U.S. legal drinking age is
- Possession or use of illicit drugs is prohibited at all times. Any issues related to illicit drugs may be directed to the attention of local authorities.
- · Follow the Dress Code while attending conference events.
- Show respect for one another. Failure to do so may lead to removal from the conference.

 Remain in character by consistently advocating the interests and representing the policies of the country assigned. To act in character also entails displaying respect for the opinions and ideas of fellow delegates, even if these opinions and ideas conflict with a given delegate's own country's priorities.

· Collaborate with fellow delegates whenever possible.

#### **Head Delegates**

- If assigned to a committee, follow the delegates expectations. If serving solely in an advisory role, follow the faculty expectations.
- · Attend and participate in head delegates meetings.

#### **Faculty Advisors**

- Make efforts to ensure that students maintain a positive and professional approach to the conference and help them understand the skills of diplomacy as practiced at NMUN.
- Serve as information resources when appropriate, but do not participate in the actual writing of resolutions or caucusing activities; participation in the committee process must be left to the student delegates and the conference volunteer staff.
- Quietly observe your students during committee sessions.
   Communication with them should take place outside of the committee rooms.
- Refrain from using academic credit and grading policies that force participation beyond a country's normal position in the UN; awards should not be a delegation's main emphasis.
- · Attend and participate in any faculty advisors meetings.

#### Guests

- Guests are required to adhere to the same expectations as all other conference attendees.
- Guests serve as observers.
- Guests may not be enrolled university students or faculty advisors and do not provide any support to a delegation. A guest is typically a school official, spouse/partner of a faculty advisor, or a funder who is interested in learning about NMUN.

## **Conduct Expectations**

#### **Sexual Harassment & Discrimination**

Sexual harassment or discrimination based on race, gender, sexual orientation, national origin, religion, age, or disability is not acceptable. Such acts are incompatible with NMUN's educational mission and are a violation of our Conduct Expectations. Violators may be expelled from the conference without compensation. General descriptions of behavior that may be considered sexual harassment can be found in the UN's Code of Conduct.

Anyone who believes they have seen or encountered sexual harassment or discrimination should bring it to NMUN's attention. We will investigate the merits of the allegations and respond appropriately. Outcomes may include taking no action, issuing a verbal reprimand, separating individuals from the conference, or any other action deemed appropriate.

#### **Dress Code**

All clothing must portray professionalism as expected in diplomatic settings. If attire is deemed inappropriate by NMUN staff, individuals may be asked to leave the session and return with appropriate attire.

Professional business attire is a business jacket (optional for DC 2020), dress shirt, tie (optional for DC 2020), slacks/skirt/dress, and dress shoes. Professional dress expectations require that dresses and skirts be knee length. Delegates should be dressed in professional business attire that reflects their self-identified gender.

- Clothing considered too casual includes sweaters, novelty jackets, shorts, sundresses/other casual dresses, ball caps, jeans, sneakers, athletic wear, and sunglasses. Clothing that exposes excessive bare skin, shows undergarments, or is otherwise revealing is inappropriate.
- It is not appropriate to display any national symbols such as flags, pins, crests, etc. on your person during sessions. All UN symbols are acceptable. If attending virtually, please ensure that your background is conducive to the spirit of creating a neutral space for negotiations. School and country flags/symbols should not be visible on your screen/person.
- Traditional dress is permitted only for delegations in whose home countries it is considered professional business dress.
   NMUN will not tolerate any attempt to portray a character using traditional cultural attire as a costume.

Faculty advisors, delegation leaders, guests, and volunteer staff serve as role models for delegates. They too are required to dress in professional business attire while participating in scheduled conference sessions.

### **Awards Criteria**

National Model United Nations (NMUN) has established criteria for evaluating delegate performance. Each element is equally important to the overall awards determination process. All committees are weighted equally, and delegations are rated using a mathematical formula that accounts for the total number of committees in which each member state is represented.




Award evaluation areas:

- Participating in committee evaluated both during formal sessions and caucusing.
- Proper use of the rules of procedure NMUN uses the rules of procedure to facilitate effective workings of committee and debate.




