Our programs provide a diverse group of informed students and their advisors a forum for addressing global concerns in a "real world" context. Conferences address important issues including regional conflicts, peacekeeping, human rights, women and children, economic and social development, and the environment. Our goal is to provide a better understanding of the inner workings of the UN as students build skills in diplomacy and compromise. In the past year, almost 6,000 university students from five continents attended our conferences in New York City, Washington, DC and Olomouc, Czech Republic.








GROWTH & DEVELOPMENT OF PARTICIPANTS

NMUN•NY - Addressing global issues in a "real world" context



April 2011: NMUN•NY brought more than 5,000 delegates from five continents to New York City. This preeminent conference simulated 20 committees selected to engage students in discussions of current global issues. The United Nations Headquarters provided an impressive backdrop. Closing sessions were held in the General Assembly Hall. In addition, final plenary sessions were held on the UN campus. Prominent speakers have included Susan F. Rice, Hillary Clinton, Michael Ignatieff and UN Secretaries-General Ban Ki-moon and Kofi Annan.

NMUN•DC - Confronting issues at the forefront of international relations

October 2010: The fourth NMUN • DC Conference, held in partnership with the Osgood Center for International Studies, draws delegates from all over the world. More than 400 students participated in discussions of issues at the forefront of international relations. The Conference included a crisis simulation in the Security Council and committee briefings by distinguished speakers from the Washington, DC diplomatic community.



NMUN•EUROPE - Milestone NMUN in Czech Republic

November 2010: This milestone conference marked the first NMUN held in Europe and included over 300 college students from around the world. Held in partnership with Palacký University Olomouc in the Czech Republic, NMUN•Europe 2010 also gave participants the opportunity to visit Olomouc's UNESCO world heritage site, and Auschwitz/Birkenau or Krakow in nearby Poland. NMUN•Europe 2012 will be held in Lille, France from 31 January - 6 February 2012.



NMUN•APEC - First specialized NMUN in US Capital

March 2011: The NMUN•APEC Conference, held simultaneously with a High Level APEC meeting in the US capital of Washington, DC hosted 185 student participants. Delegates benefited from interaction with representatives of APEC member states as they discussed issues facing the vibrant region, as well as committee briefings provided by experts and practitioners.









In addition to the content debate by student delegates, NCCA invites diplomats and experts to speak about current global issues. Their inspiration helps the next generation of leaders focus their research and career goals as they prepare to continue the important work carried out by the United Nations and its Member States. SCHOLARSHIP ASSISTANCE

The NCCA encourages all registering schools to consider ways that their student delegations can reflect the diversity of their own campuses. Limited assistance is given either as one-time awards or as multiple-year grants to help universities develop a new Model UN program.
